On the commercial airplane side, I was part of the leadership team which implemented completely new digital design software for the 787 Dreamliner.

After moving in to our Villa - which is immediately to the east of the Clubhouse - I became a regular attendee at Meetings the FV CAC Meetings held with the Community.
